Items will only be stored for either 30 or 60 calendar days after the applicable impoundment holding period checked above before they will be deemed unclaimed and classified as abandoned and forfeited to the City.

Cease and Desist Order

You are hereby ordered to cease and desist the current operation of sidewalk vending activity in the City unless you have a valid City issued Sidewalk Vending Permit, Business License, Health Permit for food from the Environmental Health Division of the County of Orange Health Care Agency, if applicable, and are complying with all other regulations contained in Chapter 5.54 of the Orange Municipal Code (O.M.C.). You were found to be engaging in sidewalk vending activity on this date and operating in violation of the City Code which resulted in the impoundment of items including but not limited to the vending cart, food, equipment, utensils, goods, or merchandise. Please contact the Code Enforcement Division or visit the City's website at www.cityoforange.org for more information on how to obtain a Sidewalk Vending Permit and comply with the City Code.

Appeal Rights (Contesting an Impoundment)

How to Contest: You may contest the decision to impound your items within 21 calendar days of the date of impoundment. Pursuant to O.M.C. Chapter 5.54, you have the right to contest the impoundment at a hearing before an independent hearing officer. To request an appeal hearing, complete the section below (Request for Appeal) or complete the online form which is available on the City's website and deliver or mail it, together with payment of the appeal hearing fee to:

Your Request for Appeal and the appeal hearing fee must be received or postmarked within twenty-one (21) calendar days of the date that your items were impounded on this notice, or you lose your right to challenge the decision of the impoundment of your items by the City.

Hearing Procedure: After you have properly requested a hearing and paid the appeal hearing fee, you will be notified in writing of the location, date, and time set for your hearing within thirty (30) calendar days. If you are unable to appear on the scheduled hearing date, you have one opportunity to reschedule and must do so promptly, otherwise you will lose your opportunity for a hearing. If you fail to appear at your hearing, you will lose your hearing fee, as well as your challenge surrounding the decision of the impoundment of your items by the City. At the hearing, you will have the opportunity to provide testimony and evidence. The City Official will also explain why the impoundment action and notice was conducted.

Written Decision: The hearing officer will issue a written decision to affirm, modify, or reverse the impoundment of your items with reasons within thirty (30) days after the conclusion of the hearing. You will receive a copy of the hearing officer's written decision within five (5) working days. If the hearing officer agrees with you then the hearing officer will require the City to return the impounded items to you within fifteen (15) business days, excluding items that were immediately disposed of because they were perishable and/or could not be safely stored, refund the hearing fee, and not be required to pay the impound fee in order to retrieve your items. If the hearing officer agrees with the City, the City shall keep the hearing fee, but you can retrieve your items after the impoundment holding period indicated and upon payment of any applicable impound fees as provided in the City Code.
