10. North End Gateway Sign

NOTES: M. Trimble We have been getting quotes from other companies. I'm working with the sign manufacture to work on the engineering and permitting. We just need a 15% deposit to start the process. We will be tying the fundraising for the sign to Lamplighter, the GQA will help match funds



to get the project off the ground and find other sponsors. We reached out to the original manufacturer and are now in possession of the original drawings including the sign design and site placement. The original manufacturer proposed a cost of \$295,000. **M. Georgopoulos** Executive Board proposed that we spend up to \$150,000 of GQA cash to get the sign done, the intent is to fundraise before and after we spend the money to recoup that \$150,000 if we feel confident that we can raise the other \$150,000 with the Alliance. **H. Greenberg** I commit to help fundraise for the other \$100,000 - \$150,000.
