DISCUSSION: J Jandinger personally opposed to the program because would like to be known as not a "discount" district. But a neighborhood of great entertainment. **D Perloff** we are spending the reimbursable income to drive people to the parking lots. Having the free apps can give us more traction. **M Trimble** we turned this program on its head because we have had some real results. **D Perloff** we might also award parking for a year, or certain promotions like free slice of pizza on one day. **J Jadinger** Horton Plaza would give us the opportunity to validate parking. **J Santos** said it removes the negative image of parking in the Gaslamp. **P Schwartz** it continues people coming to the Gaslamp throughout the year, not just for an event.

Gaslamp Hoop Madness

Howard, Michael, Vavi Entertainment, Laurel, and Aron met and have talked through the event but are waiting for the final numbers- It is the assumption that for the 2 day event, with all the bells and whistles it would be 70K. **L McFarlane** 30 K is "fluff" and looking for sponsors of the slam dunk contest, the mouth piece, etc.

DISCUSSION: P Schwartz if we can't get the sponsor to do the "fluff" **L McFarlane** then we wouldn't do the event. **H Greenberg** when will we know when the numbers will come in? **L McFarlane** not until next week. **M Trimble** so we would come to a decision on the event and its budget at a special meeting next week. Also, we would like to discuss the website decision. **P Schwartz** coming from the event business it concerns me that the event won't be good because we are planning it less than one month out. I'm also concerned that if we don't get the "fluff" underwritten, then it would be a crappy event. So no one will come next year.

DECISION: The Board of Directors decided to go forward with the event if it is up to 40K and will finalize next week at the Special Meeting at the Hotel Solamar Wednesday March 4, 3 PM

• Sidewalk Repair Project

Action Items:

- Confirmed with Downtown Partnership that they will repair four sections of badly damaged sidewalks. The funds will be request from the DSDP from NPP. Below is the following areas that will be repaired this summer.
 - 5th between G and Market 10"x9' = 90', 5' x 6'= 30, 10' x 12'= 120 total 240 sq.fit
 - Replace brick pavers
 - Cost- \$87,000
 - 4th between Market Iland 305′ 14′=4270 sq.ft
 - Replace entire sidewalk with brick pavers
 - Cost- \$154,000

Illegal Vending in the Gaslamp Quarter
